Application completed in all respect and accompanied with duly attested copies of School Certificate, ST Certificate, Self Addressed Stamped Envelope and 1 (One) recent passport size photograph should be submitted to the undersigned. Candidates from Garo Hills may submit their application to the Office of the Assistant Director Local Fund Audit, Tura. Incomplete application will be summarily rejected and no further correspondence will be entertained.


Candidates will have to appear for Viva-Voce before the Selection Committee at their own expenses if and when called for.

Age limit – Candidate should not be more than 27 years and not less than 18 years as on 1st January 2017. Upper age limit is relaxable by 5 years in case of candidates belonging to ST. Candidates who are already in Government Service must submit their application through proper channel.

Reservation of vacancies :- As per State Government policies. Since the vacancies is 9 (nine) only, all Posts are reserved for the specified communities. Person with disability have to support with medical certificate from the competent authority.

The last date for submission of application completed in all respect will be on 31st March 2017. Application received after the last date will not be entertained.

Canvassing directly or indirectly will disqualify the candidate.


