ORDER UNDER SECTION 163 BNSS

Whereas, information has been received that inhabitants of two villages are involved in cutting of fire wood at a disputed site, which has invariably led to tension between the residents of the two villages.

And whereas, if this activity of cutting fire wood at the disputed site is allowed, it may lead to break down of law and order.

Now, therefore, being so satisfied. I, Smti. Rosetta Mary Kurbah, IAS, District Magistrate, East Khasi Hills, Shillong, in exercise of the powers conferred upon me under Section 163 BNSS Do hereby prohibit the cutting of wood by the residents of Nonjrong and Kut villages at the disputed site.

Any violation of the said order will attract penal provisions under **Section 223 of the BNS and any other Section** as deemed fit and appropriate.

In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with immediate effect and remain in force until further orders.
