3. To submit its report with requisite details regarding action taken and action to be taken with timelines for execution/ completion and compliance status in respect of compliance with the environmental norms and contractual obligations by Public Works Department and executing agencies.
4. The Joint Committee may submit its report on or before the **2<sup>nd</sup> March, 2026** positively.


