**OFFICE MEMORANDUM**

**Subject:- MODIFIED ASSURED CAREER PROGRESSION SCHEME (MACPS) FOR THE STATE GOVERNMENT EMPLOYEES – clarifications regarding.**

The undersigned is directed to invite attention to Para.15 and Para.17 of this Department's O.M.No.F(PR)-59/2017/18 dated 19<sup>th</sup> December, 2017 regarding fixation of pay under the Modified Assured Career progression Scheme (MACPS) wherein it has been provided that the pay of employees whose placement Pay Level under the MACP Scheme is below or above the Pay Level of the regular promotion post shall be fixed as per provision of F.R.23(ii) of the Meghalaya F.Rs & S.Rs, 1984. Instances have come to the notice of this Department that in fixing the pay of such employees accordingly, pay in the placement Pay Level falls at the same stage as that of the last pay drawn by them in the lower Pay Level, and as a result, there is no financial benefit in the placement.

To address this problem, it has been decided that in such cases, pay shall be fixed by adding one increment to the pay arrived at in the placement Pay Level.
