Subject:- Mobile Phone Facility/Re-imbursment of recurring Expenditure thereof.

Sir,

I am directed to convey the sanction of the Governor of Meghalaya to the Reimbursement of Recurring Mobile Phone expenses @ Rs.1025 p.m. (Rupees One Thousand Twenty Five) only, for each of the following Govt. functionaries :-

1. Chief Minister (2) Deputy Chief Minister (3) Ministers (4) Minister of State (5) Chief Secretary (6) Additional Chief Secretary (7) Principal Secretaries (8) Commission & Secretaries (9) Secretaries (10) Director General of Police (11) Additional Director General of Police (12) Principal Chief Conservator of Forest (13) Deputy Commissioners and (14) Superintendent of Police's.

The Re-imbursment shall be made by the Secretariat Administration Department (Accounts) in respect of those drawing monthly salary from the Secretariat Administration Department (Accounts) and by the respective Departments in respect of others. The re-imbursment shall be made on the basis of an Expenditure Certificate/Payment Vouchers in respect of expenditure incurred. Expenditure in excess of the ceiling aforementioned shall have to be borne by the Govt. functionaries themselves.

The aforementioned Govt. functionaries shall have to bear the cost of the handset, registration fee, activation charges and Security Deposit etc. They are at liberty to avail the services from any Service provider.

The Re-imbursment facility shall come into effect from 1st November, 2004.

Govt. functionaries/Officers who have been granted the Mobile Phone facility prior to the issue of this order shall continue to enjoy the same facility under such (earlier) sanctions.
