OFFICE MEMORANDUM

Subject:- Mobile Phone Facility.

In continuation to this Department's Memo.No.GAB.13/2004/13 dt.3.11.2004 and Memo.No.GAB.13/2004/30 dt.28.09.2005, the Governor of Meghalaya is pleased to grant extension of the Mobile Phone facility to the following Government functionaries/Officers for official purpose at Government expense.

1. Additional Secretaries to the Govt. of Meghalaya.
2. Joint Secretaries to the Govt. of Meghalaya whose pay scale are equivalent or higher than Head of Department's.
3. Officer on Special Duty to the Govt. of Meghalaya whose pay scale are equivalent or higher than Head of Department's.

The facility shall not however include the cost of the hand set, registration/Activation/Security Fee or deposits, but shall include the recurring monthly rental and call charges subject to a maximum ceiling of Rs.1025/- (Rupees One Thousand twenty five)only. Excess expenditure over the prescribed maximum ceiling shall be borne by the Government functionaries/Officers themselves.

The aforesaid recurring monthly expenses shall be re-imbursed to the Government functionaries/Officers strictly on production of payment vouchers/Receipts or Expenditure Certificate. The re-imbursement shall be made by the Secretariat Administration Department in respect of those who are drawing their salary from the Secretariat Administration Department (Accounts) and by the respective Heads of Department's in respect of others.

This order concurred to by Finance Department vide I/D.No.FC(I)8/06-07 dt.7.04.06 comes into effect from the date of issue of the order.
