1	Honorarium	Rs.7,500/- per month.
2	Conveyance	Rs.7,500/- per month.
3	Medical Benefit	Free medical benefits for the incumbent only for treatment outside the State as recommended by the DHS (MI).
4	Electricity	Rs.1,000/- per month.
5	House Rent	Rs.5,000/- per month.
6	Hospitality	Rs.1,000/- per month.
7	Grade-IV (Peon)	One in office.
8 .	TA/DA	Actual subject to a maximum of Rs.8,000/- per month for local tours. Tours outside the State will be admissible only if the same is performed as a Committee subject to prior approval of Chief Minister / Minister incharge.

Persons appointed in this category will be deemed to be appointed under Category 'B'.

The Honorarium and other facilities as shown above may also be made applicable to any other such functionary as the Chief Minister may decide to appoint under this category from time to time.

This order will take effect from April 20, 2010 or the date of joining of the incumbent, which ever is later.
