F-2 form of tender agreement duly affixed with a non-refundable court fee stamp of **Rs. 2000.00 (Rupees Two Thousand)** only are hereby invited in **2 (two)** cover bid system i.e. Technical and Financial Bid by the undersigned on behalf of the Governor of Meghalaya from Registered Class-I, P.W.D. (Roads) contractors of Meghalaya State for the under mentioned work and will be received in this office (in Room No. 210) **upto 3:00 P.M. of 5th February 2026**. The tenders will be opened on the same day at **3:30 P.M.** in presence of the tenderers or their authorized representatives who so desire to witness the opening of the bids. If the date of receiving of tenders happens to be a holiday, the next working day will be considered as the date of receiving and opening of tenders.
