Whereas, information has been received that Bridge No. 1/1 at Nongspung – Laitmawsiang Road and vice versa has been damaged.

And Whereas, the Bridge has the capacity of supporting only upto 9(Nine) tonnes, And that plying of heavy loaded vehicles has left the bridge frail. And there is likelihood that this will cause more damage to the Bridge.

And Whereas, renovation of the deck slab is still going on. And it is necessary to prevent any further damage to the Bridge for safety and security of public and villagers at large.

Now, therefore, being so satisfied. I, Smti. Rosetta Mary Kurbah, IAS. District Magistrate. East Khasi Hills, Shillong, in exercise of the powers conferred upon me under Section 163 BNSS do hereby prohibit heavy loaded vehicles more than 9(Nine) tonnes from plying through Bridge 1/1 at Nongspung – Laitmawsiang Road.

Any violation of the said order will attract penal provisions under **Section 223 of the BNS** and any other **Section** as deemed fit and appropriate.

In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with immediate effect and remain in force until further orders.
