SPECIAL INTENSIVE REVISION (SIR) 2026 - PRESS NOTE

The Special Intensive Revision (SIR) of Electoral Rolls, 2026, in East Jaintia Hills District has progressed to the **Notice and Hearing stage**. The latest position as on 25th September, 2026 at 5:57 AM indicates that substantial progress has been made in the verification and hearing of cases in 5-Sutnga Saipung (ST) and 6-Khliehriat (ST) Assembly Constituencies.

A total of 28,673 notices have been generated, of which 28,623 (99.83%) have been delivered to the concerned electors. Hearings have been completed and documents uploaded in 23,345 cases. 50 notices remain pending for delivery.

However, 5,327 cases remain pending due to absence of document(s), etc. This constitutes the largest remaining workload in the Notice and Hearing process. Of these, 3,364 cases are in AC-06 Khliehriat and 1,963 cases are in AC-05 SutngaSaipung.

Appeal to Electors

The District Election Officer, East Jaintia Hills, makes an earnest appeal to all electors whose cases are pending for want of documents to come forward without further delay and produce the required documents before the concerned election authorities.

Electors who have received a notice are requested to contact their respective BLO/concerned election office and cooperate with the hearing and verification process. Timely submission of the required documents will enable the authorities to examine and dispose of the cases in accordance with the prescribed procedure.

It is important to clarify that a case pending due to absence of documents is not, by itself, a declaration of **ineligibility**. Such cases remain subject to the prescribed verification and disposal process. The current report records 27 cases as found ineligible for final, separately from the 5,327 cases pending for documents/other reasons.
