In continuation of **Order No. POL/2020/PtI/116 dated 3rd January 2022**, the following activities are permitted in the State of Meghalaya with effect from 5th January, 2022:

- There will be no requirement for Covid testing for inter-state transit movement of goods or passengers through Meghalaya provided the vehicles do not stop anywhere in the State.
- There is no requirement for Covid testing for persons engaged in movement of goods into the State provided they restrict their movement to their area of operation. Drivers of such vehicles should be vaccinated and Deputy Commissioners may conduct regular random checks.
- 3. Persons working in State/Central Government offices, banks, private offices, commercial establishments who require inter-state movement and enter and exit the State on the same day, are exempted from undergoing such Covid tests provide they restrict themselves to their respective offices/establishments and they are vaccinated.
- Persons from Meghalaya transiting to various parts of the State via Assam are exempted from Covid testing. For example, persons from Garo Hills travelling to Khasi Hills and Jaintia Hills and vice versa.

Deputy Commissioners of the concerned districts shall issue directions/orders accordingly.
