

NOTICE

This is for the information of the general public and applicants in particular who are applying for various posts advertised by the Meghalaya Public Service Commission vide No. MPSC/ADVT-54/1/2020-2021/45, Dated 22nd December, 2021 that the upper age limit for entry into Government Service is hereby enhanced from 27 to 32 years i.e, he/she must not have exceeded the age of 32 on the first day of the year of advertisement. Candidates belonging to Scheduled Tribes and Schedules Castes will continue to enjoy a further relaxation of 5 years over the upper age limit of 32 years.

The new upper age limit will be applicable in case of all categories of posts except for certain categories of posts as may be notified by the Personnel & A.R(A) Department for the Home (Police), Excise Registration, Taxation and Stamps, Home Guards & Civil Defence, Prisons and Forests & Environment Departments.

This is as per Government Office Memorandum No.PER.38/2021/30, Dated Shillong the 3rd February, 2022.







PARA 3: SUBMISSION OF APPLICATION

Candidates are to apply and submit their applications through Online mode only by clicking on the "Online Application" icon appearing in the MPSC website viz www.mpsc.nic.in. Applications received through any other mode will not be accepted and will be summarily rejected.

For candidates applying for the first time through Online mode, a one-time registration process is required to enable them to apply against the advertised vacancy/post. Kindly read the instructions on the web page carefully before applying. Last date for online application is 17: 00 hrs on **11.03.2022**

Candidates who have already registered with the Commission's website may log in and apply directly against the advertised vacancy/post indicated above.

PARA 4. Payment of Application Fees

Candidates who wish to apply may pay the application fees using any one the following modes of payment only:-

e-Challan/Cash Payment at any branch of SBI :- Candidates may also opt for Cash Payment at any of the branches of SBI. For cash payment, please select Payment across Bank Counter. Fill in the required details, an e-Challan will be generated. Take a printout of the e-Challan and make the required payment at any branch of SBI. Please note that you need NOT submit the e-Challan to MPSC.

Kindly note that an additional amount in the form of Bank's commission may be applicable depending upon the mode of payment. **The amount once deposited shall not be refunded or adjusted against any other purpose.**

PARA 5: INSTRUCTIONS

- I. Applicants are advised to apply well in advance without waiting for the closing date.
- II. Candidate must appear for Written Examinations/Interview at his/her own expenses.

Admission at all stages of the recruitment process for which the candidates are admitted by the Commission will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the recruitment process, it is found that applicants/candidates do not fulfill any of the eligibility conditions, their candidature for the post will automatically be cancelled by the Commission without notice.

PARA 6: RESERVATION OF VACANCIES

As per Reservation Policy of the Government of Meghalaya.

PARA 7: COMMISSION'S DECISION ON ELIGIBILITY OF CANDIDATES

In eligible candidates will be rejected before publishing the results of the Preliminary Examination and the ineligibility list shall not be published.

PARA 8: METHOD OF SELECTION

The final selection/ recommendation of suitable candidates against the vacancies notified in this Advertisement shall be made by the Commission through the following processes.

1. Preliminary Screening Test \Rightarrow Main Examination \Rightarrow Personal Interview

I - **Written Examination**- This shall be mandatory as specifically prescribed in Service Rules for the conduct of such examinations. The subjects, syllabus, total marks and pattern of examination shall be as notified by the concerned Government Department under such Rules.

II - **Preliminary Examination** - The Commission may, at its discretion, decide to hold Preliminary Test in those categories of recruitment where the number of candidates are disproportionately large compared to the notified vacancies **or** may/will hold the Preliminary Examination as per requirement in the syllabus provided in the Service Rule for the Service.

III - **Main Examination**- On the basis of such Preliminary Tests, the number of candidates who shall be called to appear for the Main Examination shall not be more than 10(ten) times the number of vacancies declared.

IV - **Personal Interview**- On the result of such Written Examination, the Commission shall call such number of candidates as it may think appropriate to appear for the Personal Interviews. The principle/policy followed is as per decision made by the Commission on 28th July, 2017 with variation from 1:10 to 1:2.5 depending on the number of posts advertised.

***Only candidates who have produced all the required documents in original relating to their educational qualification, date of birth, caste, community and other certificates wherever required and prescribed by Rules will be deemed qualified to be called for Personal Interview.

Multiple Choice OMR based Test-

Preliminary Examination shall be of Multiple Choice OMR based Tests. The subjects for the Multiple Choice OMR based Tests shall be as follows :-

SECTION - II

1. General English – Marks to be specified as per the standard and qualification for the post.


2. Any other subject to be included as per the standard and qualification for the post.

Essay Type Test –

Written Examination/Main Examination where decided to be held shall be of Essay Type. The subjects to be notified for such essay type examination shall be strictly as per the syllabus forwarded by the concerned Department for the said post.

PARA 9: DEBARMENT

- (a) Candidates should make sure of their eligibility for the post applied for and that the declaration made by them in the format of application regarding their eligibility is correct in all respects. Any candidate furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable TO BE DEBARRED FROM APPEARING FOR ANY OF THE EXAMINATIONS CONDUCTED BY THE COMMISSION, and summarily their candidature for this recruitment will be rejected.
- (b) The Commission is vested with the constitutional duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by anyone causing or likely to cause breach of this constitutional duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Commission will be sufficient cause for rendering such questionable means as ground for debarment.
- (c) If any candidate is or has been found impersonating or procuring impersonation by any person or resorting to any other irregular or improper means in connection with his/her candidature for selection or obtaining support of candidature by any means, such a candidate may in addition to rendering himself/herself liable to criminal prosecution, will be liable to be debarred permanently from any exam or selection held by the Meghalaya Public Service Commission.


