- (2) Admission to all stages of the recruitment process for which the candidates are admitted by the Commission will be purely **Provisional** subject to satisfying the prescribed eligibility conditions.
- (3) Applicants are advised to ensure their eligibility with regards to the educational qualification, age and other criteria as required in the post. If an applicant is found not fulfilling any of the eligibility conditions, at any stage of the recruitment process and including the last stage of process of recruitment ie "Recommendation", the candidature for the post shall be automatically cancelled by the Commission without notice.

#### PARA 6: COMMISSION'S DECISION ON ELIGIBILITY OF CANDIDATES

#### PARA8: DEBARMENT
