ORDER

No. PSD/GEN/Health/Pt-II/01/2021/143: In compliance with Order No. POL.75/2020/Pt.I/106 dated 16/07/2021 issued by Home (Political) Department, Government of Meghalaya, Shillong and Order of the Deputy Commissioner issued vide No.C&S/CVD/2021/ORD/205 dated 17/07/2021, permitting upto 50% of Commercial Vehicles per day within the Civil Sub-Division areas, the following arrangement of Local Taxis and Auto Rickshaw will take effect from 19th July, 2021 to 24th July, 2021 from 6:00 AM to 6:00 PM as per details indicated below subject to the following conditions:-

| 22 nd July, 2021 (Thursday) | Vehicles ending with 1,3,5,7 & 9 |
| 23 rd July, 2021 (Friday) | Vehicles ending with 0,2,4,6 & 8 |
| 24 th July, 2021 (Saturday) | Vehicles ending with 1,3,5,7 & 9 |

1. There will be no transportation of passengers to Shillong Urban Agglomeration and its adjoining areas. Movement into Shillong Urban Agglomeration and its adjoining areas will only be for essential reasons and with passes duly obtained from the SDO (C) concerned.
2. Seating Capacity will be strictly adhered to as follows:-

| Vehicles | Seating Capacity |
|-----------------|------------------------------------|
| Bus | 50% or not more than 2 + 16 |
| Local Taxi | 1 + 3 |
| Auto Rickshaw | 1 + 2 |

3. Vaccination Status should be clearly indicated on the vehicles and **any violation will invite strict action as per Law.**
4. Wearing of double mask or N-95 is mandatory, even for a single person driving a vehicle. In case of persons travelling in any private car with valid pass or authorization, up to 100% of its seating capacity, wearing of double mask or N-95 is mandatory for all the persons. Use of sanitizers is mandatory. Proper ventilation of the vehicle is advisable.
5. All Public transport authorities shall strictly enforce COVID-19 appropriate behavior and seating inside the vehicles.

Violation of any norms and advisories of the Government of Health and Family Welfare Department and this office will be liable for action as per Law by the appropriate authority.
