

**GOVERNMENT OF MEGHALAYA

ORDER

No. POL.75/2020/PtI/89

Dated: Shillong the 21st April, 2021

In view of the rapidly rising COVID-19 cases in the State, it has become necessary to notify additional restrictions on permitted activities.

Now, therefore, in continuation and partial modification to Order No. POL.75/2020/PtI/88 Dt.19-04-2021, the restrictions on permitted activities are revised as follows:

1. All tourist spots in East Khasi Hills District shall remain closed from 23rd April, 2021 up to 30th April, 2021.

For Shillong Urban Agglomeration:

2. All Colleges and Skill Training Institutes shall remain closed up to 3rd May, 2021. MBOSE examinations shall continue as per schedule.
3. All bars, clubs, cinema halls, salons / beauty parlours, yoga institutes, gymnasiums, cyber cafés, gaming parlours and swimming pools shall remain closed from 23rd April, 2021 up to 30th April, 2021.
4. Personnel of State Government Departments as notified by Personnel & A.R (A) Department vide Notification No. PER.62/2020/28, dated 19-04-2021 shall work from home. All other Departments shall function at 100% strength for Group 'A' & Group 'B' officers and at 30% strength for Group 'C' & Group 'D' staff.
5. Central Government offices shall function at 100% strength for Group 'A' & Group 'B' officers and at 30% strength for Group 'C' & Group 'D' staff.
6. Private offices to function at 30% employee-strength.
7. All Essential Services Government Departments (Home, Police, Fire & Emergency services, Electricity, etc) shall continue to function at 100% strength.
8. Non-essential shops as notified by the Deputy Commissioner, EKH shall remain closed from 26th April, 2021 up to 2nd May, 2021.

Despite repeated advisories, it is still observed that SOPs relating to COVID-appropriate behaviour are not being followed strictly by all citizens. ***Citizens are advised to exercise caution, follow all protocols and adhere to the SOPs to ensure that the State does not see a resurgence in cases.***


All Deputy Commissioners and Superintendents of Police are to intensify the enforcement measures for strict compliance of the protocols and social distancing norms. They shall strictly impose fines on violators and send a Daily Report on the fines collected to the Home (Political) Department, Government of Meghalaya.

Deputy Commissioners may regulate the schedule and timing of activities. They may also restrict the activities depending on the local COVID situation and to meet the social distancing norms.
