PRESS NOTE

Review Meeting of the Electoral Roll Observer on the Special Intensive Revision (SIR) with the East Khasi Hills District Administration and Representatives of Political Parties on the 14th August 2026 in the Conference Room, DC's Office, Shillong at 10.30 AM.

The meeting was chaired by Shri. Abhilash Baranwal, IAS, District Election Officer, East Khasi Hills in the presence of Smti. R.M. Kurbah, IAS, Electoral Roll Observer for East Khasi Hills District, the Electoral Registration Officers and Assistant Electoral Registration Officers of all the Assembly Constituencies and representatives from the registered national and state parties.
