- (vii) South Garo Hills District, Baghmara (2 vacancies)


As per Rule 4(2) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rule, 2020, the eligibility criteria is as follows:-

- (i) The applicant should not be less than thirty-five years of age;
- (ii) The applicant should possess a Bachelor's degree from a recognised University; and
- (iii) The candidate should be a person of ability, integrity and standing and having special knowledge and **profession experience of not less than 15 (fifteen) years** in Consumer Affairs, Law, Public Affairs, Administration, Economics, Commerce, Industry, Finance, Management, Engineering, Technology, Public Health or Medicine.

The applicant upon selection for the post of Member of the District Commission, shall have tenure of four years or up to the age of sixty-five years whichever is earlier.

Application may be submitted in attached format to the office of the Deputy Commissioner (Supply) in District concerned on or before 28th March, 2026.

Note:-Persons who do not fulfil the above criteria need not apply.
