The Government of Meghalaya, Finance (Pay Revision) Department vide its O.M No.F (PR)-47/2009/Pt.I/79 dated 14-02-2017 having sanctioned Dearness Allowance to State Government Employees of Meghalaya, w.e.f 1-7-2016, I am to authorise to make payment of this revised rate of Dearness Allowance to the serving Gazetted Officers of the Government of Meghalaya, w.e.f 01-07-2016 at the rate shown at para 3, below, by production of Bills in respect of the cases of the officers concerned, without insisting on individual Authority from this office. This present rate of Dearness Allowance is inclusive of the rate of Dearness Allowance sanctioned earlier vide Finance (PR) Department, Meghalaya, O.M No F (PR)-47/2009/Pt.I/75 dated 01-06-2016 and authorised.

2. This authority remains valid till pay slip(s) incorporating the present Dearness Allowance is/are issued by this office in respective cases of the officers.

Note:- (i) The payment on account of the Dearness Allowance shall be rounded off the nearest Rupee.

(ii) The Pay for calculation of the Dearness Allowance shall be as defined in F.R.7(17)(i) of the Meghalaya FR's & SR's 1984.

4. The expenditure on this account shall be debitable to the respective Heads of Accounts from which the officers draw their Salary.
