Terms of Reference

- (i) Assess the availability of timber in the state by way of appropriate study on demand and supply as and when the State Level Committee accordingly decides. The Committee shall devise suitable mechanism for sustainable use of timber in a way that does not affect the forest of the area adversely.
- (ii) Consider and approve the name of Wood Based Industries for grant of fresh license, renewal of license granted to the Wood Based Industries or enhancement of the existing capacity of the licensed Wood Based Industries in case the State Level Committee is satisfied that timber of legal origin is available such as trees outside forest, forests, etc. for the said new Wood Based Industries.

- (iii) Ensure that the sum lying with the respective Division of the State Forest Department which have been recovered from Wood Based Industries is utilized for the purpose of afforestation only.
- (iv) Examined and make appropriate recommendations or take up any other matter referred by the State Government to the Ministry of Environment Forest and Climate Change.

The Notification issued vide this Department's No.FOR.50/2001/Vol I/747, dated 11/12/2023 is treated as cancelled.
