DECIDED THAT AS IN THE PREVIOUS YEARS TWO MINUTES SILENCE WILL BE OBSERVED AT 11:00 AM ON THE 30<sup>TH</sup>  
JANUARY 2026 (FULLSTOP) PARA (FULLSTOP) THE FOLLOWING PROCEDURE WILL GOVERN THE OBSERVANCE OF THE  
DAY MENTIONED ABOVE (FULLSTOP) PARA(1) SILENCE SHOULD BE OBSERVED AND WORK AND MOVEMENT STOPPED  
FOR TWO MINUTES THROUGHOUT THE STATE AT 11:00 AM ON 30<sup>TH</sup> JANUARY 2026 (FULLSTOP) PARA (2) WHEREVER  
FEASIBLE (COMMA) THE COMMENCEMENT AND TERMINATION OF THE TWO MINUTES SILENCE PERIOD SHOULD BE  
INDICATED BY SOUND OF SIREN OR ARMY GUNS (FULLSTOP) SIRENS SHOULD BE SOUNDED FROM 1059 HOURS TILL  
1100 HOURS AND AFTER TWO MINUTES (COMMA) ALL CLEAR SIRENS SHOULD AGAIN BE SOUNDED FROM 1102  
HOURS TILL 1103 HOURS (FULLSTOP) THIS PROCEDURE MAY BE ADOPTED WHERE SIRENS EXIST (FULLSTOP) PARA (3)  
ON HEARING THE SIGNALS WHEREVER AVAILABLE (COMMA) ALL PERSONS WOULD STAND UP AND OBSERVE THE  
SILENCE (FULLSTOP) PARA (4) AT PLACES WHERE NO SIGNAL SYSTEM IS AVAILABLE (COMMA) SUITABLE INSTRUCTIONS  
CAN BE ISSUED TO ALL CONCERNED FOR OBSERVING THE SILENCE FOR TWO MINUTES AT 11:00 AM (FULLSTOP) THE ALL  
INDIA RADIO SHOULD STOP BROADCASTING AND TRAFFIC ON THE ROAD SHOULD COME TO A STAND STILL FOR TWO  
MINUTES (FULLSTOP) KINDLY TAKE NECESSARY ACTION ACCORDINGLY (FULLSTOP) MESSAGE ENDS (FULLSTOP)**
