Dated Shillong, the 21<sup>st</sup> November, 2011.

No. LJ (A) 23/85/Pt./212- In exercise of the powers conferred by rule 28A of the Meghalaya Judicial Service Rules, 2006 as amended in 2007, the Governor of Meghalaya is pleased to relax as a special case the provision as contained in Sl. No. 2 of the Proviso to rule 8 of the said Rules, that the existing 3 (three) posts in Grade II of the services out of 7 (seven) posts shall now only be filled by direct recruitment as a one time measure in view of shortage of suitable Judicial Officers in Grade III of the Services at present. 4 (four) posts shall be kept for promotion of the existing Judicial Officers Grade III. This relaxation shall be a one time exercise and shall not be treated as precedence.

This issues in pursuance of Resolution No. 3 of the Minutes of the Meeting regarding Separation of Judiciary and Allied Matters of the State of Meghalaya held on 01.11.2011 at 4.30 P.M. in the office chamber of Hon'ble the Chief Justice and supercedes this Department's Notification No. LJ (A) 23/85/Pt/188 dt. 18.11.2011.


