**NOTIFICATION**

**Dated Shillong, the 16<sup>th</sup> October, 2020**

**No.DCA.1/2020/148:-** Whereas, the Governor of Meghalaya, in exercise of the powers conferred by sub paragraph (2) of Paragraph 16 of the Sixth Schedule to the Constitution of India has assumed to himself the administration of the Garo Hills Autonomous District with effect from the 19<sup>th</sup> October, 2020 for a period of six months or till the Constitution of the new Council through election, whichever is earlier, vide his Order published in the Notification No.DCA.1/2020/146 dated Shillong, the 16<sup>th</sup> October, 2020;

And, whereas, under paragraph (b) of the said Order the Governor may also appoint such person or authority for the discharge of the functions and powers of the Garo Hills Autonomous District Council;

Now, therefore, in exercise of the powers conferred by paragraph (b) of the aforesaid order, the Governor is pleased to appoint the Commissioner of Division for Garo Hills to exercise all the functions and powers exercisable by the Executive Committee, Chief Executive Member, Deputy Chief Executive Member, Chairman, Deputy Chairman and Executive Member for the aforesaid District Council subject to such direction as may be issued by the Governor from time to time;

In exercising the functions and powers under this order the Commissioner of Division for Garo Hills shall be designated as the "Administrator, Garo Hills Autonomous District Council."
