**No. FOR.53/2019/201:-** Whereas the Transport Department, Govt. of Meghalaya issued Notification No.TPT.101/2020/Pt/309 dated 29-06-2020 notifying the maximum safe axle weight of each axle type in relation to the transport vehicles. Pursuant to Transport Department's Notification, it has become necessary to also notify the permissible quantity for issuing Transport challans for transport of minor minerals for each type of vehicle, as under -

2.	3 Axle Trucks	Two tyres on front axle and eight tyres on rear axle (10 Tyres)	21.00
3.	4 Axle Trucks	Two tyres each on two axles and eight tyres on one tandem (two) axle (12 Tyres)	27.00
4.	5 Axle Trucks	Two tyres each on three axles and eight tyres on one tandem (two) axle (14 Tyres)	34.00
