NOTIFICATION

Whereas there is a need to reorganize the Civil Defence set up in the State subsequent to the creation of new Districts to make the jurisdictions of Civil Defence District co-terminus with the jurisdictions of Districts. Therefore, in exercise of the powers conferred by Section 4(1), 4(2) and 17 of the Civil Defence Act, 1968, the Governor of Meghalaya hereby reorganizes the Civil Defence set-up in the State as below:-

The District Magistrate is the Executive Head of the Civil Defence Organisation in the District. He or she is responsible for implementing the Civil Defence Measures for protection of civilian lives during war and external aggression enumerated in Civil Defence Act, 1968. This include preparation of Civil Defence Plan, maintenance of Civil Defence Control Room, Air Raid Sirens, and VHF Communication with Other Civil Defence Towns in the state. He conducts various training on Civil Defence on Civil Defence subjects and Disaster Management.

The Director General, Civil Defence & Home Guards shall coordinate the activities of the Controllers in the State.


