## Background:

The State Broadband Committee for Meghalaya is setup for proliferation of broadband in the State through the effective implementation of the National Broadband Mission (hereinafter referred to as the Mission). The Mission was launched on 17<sup>th</sup> December 2019 with the vision "To enable fast track growth of digital communications infrastructure, bridge the digital divide for digital empowerment and inclusion, provide affordable and universal access of broadband for all. To steer, drive and achieve the Mission's objectives, the National Broadband Mission is set up in the Department of Telecommunications. The Mission will consist of Governing Council for Broadband at Apex Level chaired by the Union Minister of

Communications; Broadband Steering Committee chaired by Union Secretary, Department of Telecom and the State Broadband Committee chaired by the State Chief Secretary.

The functions of the State Broadband Committee shall be as follows:

(a) To advice, either suo-motu or on a request of the Governing Council or Steering Committee on the matters relating to the accomplishment of the objectives of the National Broadband Mission concerning the State.

(b) To facilitate implementation of the guidelines issued by the Governing Council or § Steering Committee enabling expansion of broadband services for the socio-

economic development of the State.

(c) To address all matters regarding Broadband Readiness Index (BRI)

(d) Monitoring and evaluation of the work of the Mission pertaining to the State.

The Committee shall meet once every quarter and may call other Departments of the State Government and experts as per requirement.

The "Digital Connectivity State Level Monitoring Committee for Meghalaya" as per Notification No. ITR.54/2010/Pt.1/389 dated 30th April, 2018; shall be merged/ subsumed under the State Broadband Committee for Meghalaya.
