
1. Goods Carrier (2-Axles above):-

Type of vehicle	Axle Combination	Permissible quantity for issuing Transport Challan in MT
2 Axle Trucks	Two tyres on front axle and four tyres on rear axle (6 Tyres)	12.00
3 Axle Trucks	Two tyres on front axle and eight tyres on rear axle (10 Tyres)	21.00
4 Axle Trucks	Two tyres each on two axles and eight tyres on one tandem (two) axle (12 Tyres)	27.00
5 Axle Trucks	Two tyres each on three axles and eight tyres on one tandem (two) axle (14 Tyres)	34.00

2. Goods Carrier (Single Axle):-

Type of vehicle	Permissible quantity for issuing Transport Challan in MT
Tata 407 Ex	3.83
Tata 709	4.775
Tata 909	7.550
