No. ERTS (T) 24/2016/69 - In exercise of the powers conferred by sub-section (1) of section 112 of the Meghalaya Value Added Tax Act, 2003 (Act No. 2 of 2005 as amended) and in supersession of the Government Notification No. ERTS(T)24/2016/58, dated 15.03.2017, the Governor of Meghalaya is pleased to make the following amendment in Sl. No. 1 of Schedule V to the Act as follows:

Sl. No.	Description of Goods	Rate of Tax
1.	Liquor including foreign liquor, whether made in India or not, including brandy whisky, vodka, Gin, Rum, liquor, Cordials, Bitters and wines or a mixture containing any of these, as also beer , ale, porter, cider, parry, country spirit and other similar potable fermented liquors except rum sold to the defence personnel in Defence Service Canteens strictly for personal consumption	37.5%


