## NOTIFICATION Dated Shillong, the 1<sup>st</sup> May, 2017.

No.DCA.27/2017/5: Whereas, the Governor of Meghalaya has by order No.DCA.81/2015/Pt/4 dated 4<sup>th</sup> April, 2017 made under sub-paragraph (2) of Paragraph 16 of the Sixth Schedule to the Constitution of India assumed to himself the administration of the Garo Hills Autonomous District Council;

And, Whereas, for the purpose of administration of the said District Council by the Governor, it is necessary to make provisions for the authorization of expenditure from the District fund of the Garo Hills Autonomous District Council towards defraying the several charges which will come in course of payment in respect of the grants and services of the said District Council during the period of operation of the order aforesaid;

now, therefore, in exercise of powers conferred by sub-paragraph (2) of paragraph 7 of the Sixth Schedule to the Constitution and all other powers enabling him in this behalf, the Governor is pleased to make the following rules, namely:-

- 1. Short title, extent, commencement and duration:-(1)These Rules may be called the Garo Hills Autonomous District (Authorization of Expenditures) Rules, 2017.
  - (2) They shall extend to the whole of the Garo Hills Autonomous District.
  - (3) They shall be deemed to have come into force on and from the date of issue in the Official Gazette and they shall remain in force during the period of operation of the said order made by the Governor under sub-paragraph (2) of paragraph 16 of the Sixth Schedule to the Constitution of India.
- 2. Authorization of Expenditure:- (1) Notwithstanding anything to the contrary in any law for the time being in force in the Garo Hills Autonomous District, the Governor may, at any time authorize by order, such expenditure from the District fund of the Garo Hills Autonomous District Council as he may deem necessary in respect of such grants and services of the said District Council and for such period not exceeding six months at a time as may be specified in the order or orders:

Provided that the Governor may, at any time, authorize such further expenditure as he may deem necessary from the said District fund in respect of any grant or services.

(2) The Governor may make separate orders to these rules in respect of periods falling in different financial year.
