No.ERTS(S) 5/2019/136 ---- In exercise of the power conferred by sub-rule (1) of Rule 31 of the Meghalaya Stamps (Payment of Duty by means of E-Stamping ) Rules, 2020 and in pursuance of clause (ii) of Para 1.1 of the Agreement dated 29.06.2021 signed between the Authorized Representatives of the Government of Meghalaya and the Stock Holding Corporation of India Limited for implementation of the Computerized Stamp Duty Administration System in the State of Meghalaya with the objective of promoting Ease of Doing Business, the Government of Meghalaya is pleased to allow Stock Holding Corporation of India Limited to integrate with the web portal of National e-Governance Services Limited (NESL) for collection of stamp duty and issue of dematerialized Digital form of e-Stamp for the paperless execution of the non-registrable documents listed below..

The stamp duty chargeable shall be as per the appropriate articles of Schedule 1-A of the Indian Stamp Act ,1899 as applicable to the state of Meghalaya and in the absence of any proper article under Schedule 1-A, as per Schedule 1 of Indian stamp Act, 1899 as applicable by parties concerned for the following documents:


