- (2) On the receipt of acknowledgement of payment from each of the empanelled RQP the application along with all documents furnished will be forwarded by the Commissioner of Taxes within 3(three) working days of receipt of the acknowledgement, to each of the empanelled RQP.
- (3) The empanelled RQP shall submit the report within the period prescribed under clause (b) of Rule 6 of the Rules, counting from the date of issue of the forwarding letter.
