No.FOR/CC/18/2022/14 :- In supersession of this Department's Notification No.FOR/CC/18/2022/11, dated 6th June, 2022, and in pursuance of Order dated 28.04.2022 of the Hon'ble National Green Tribunal (Principal Bench), New Delhi, in Original Application No.192/2022 in the Matter of "*In re: News Item Published in The Shillong Times Dated 23.02.2022 Titled "Poison Flowing in Shillong's Rivers: Water Quality Index"*", the Governor of Meghalaya is pleased to constitute a Joint Committee of Central Pollution Control Board and Meghalaya State Pollution Control Board to look into the alleged violations reported on the release of untreated sewage into river Umshyrpi near Shillong Law College and River Wah Umkhrah at Demthring and release of effluents in river Lukha for taking necessary action in accordance with the law:-

Terms of Reference:-

1. The State PCB will be the Nodal Agency for compliance.
2. The Committee will look into the alleged violations and take further action in accordance with law.
3. The Committee will be free to interact with concerned authorities and stakeholders.
4. The Committee may also consider the Action Plan prepared by the River Rejuvenation Committee (RRC) for rejuvenation of Wah Umkhrah and Umshyrpi rivers and take further action in accordance with the law.
5. Action Report to be furnished to the Tribunal within 2 (two) months by e-mail.
