ORDERS BY THE GOVERNOR

NOTIFICATION

Dated Shillong, the 8th September, 2021

NO.FOR.24/2021/39 :- In accordance with the provisions of Section 36 C of the Wild Life (Protection) Act, 1972(as amended upto 2006), the Governor of Meghalaya is pleased to declare the Community Forest of Aritakgre Village in South Garo Hills District, as a Community Reserve to be known as the "Aritakgre Community Reserve" with immediate effect as per the schedule of boundaries indicated below:-

Schedule of Boundaries:-

NORTH : The northern boundary starts from a point located on a small stream at point No.1 at 25°11'32.350"N 90°27'25.330"E then it proceeds in North-Eastern direction along the small stream till it reaches point No. 2 at 25°11'32.274" N 90°27'26.089"E then it proceeds South-eastern direction along the same stream through point No. 3 at 25°11'31.482" N 90°27'26.786" E, point No. 4 at 25°11'30.487" N 90°27'27.104"E up to point No. 5 at 25°11'29.649"N 90°27'27.936"E. From the point No. 5, the boundary proceeds in North-eastern direction along the Kapasipara Aking Land boundary till it reaches point No. 6 at 25°11'30.856" N 90°27'29.687"E then it proceed North Eastern direction to point No. 7 at 25°11'31.790"N 90°27'31.318"E then it continue to proceed Eastern direction along the boundary of the same till it reaches point No. 8 at 25°11'31.381"N 90°27'33.283"E. From point No. 8 it run Southern direction along the same land boundary till it reaches point No. 9 at 25°11'30.492" N 90°27'33.453" E, then it continues in South Eastern direction along the same boundary of the said Kapasipara A'king Land till it reaches point No. 10 at 25°11'28.614"N 90°27'36.810"E then it continue to proceed further North-Eastern direction till it reaches point No. 11 at 25°11'30.341"N 90°27'37.786"E then it continues in North-Eastern direction till it reaches point No. 12 at 25°11'31.405 N 90°27'40.302 E. From point No. 12 the boundary proceeds in Southern direction along the Aritakgre A'king Land boundary till it reaches point No. 13 at 25°11'27.636 N 90°27'39.858 "E then it continue to proceeds further Southern direction along the same A'king Land boundary to point No. 14 at 25°11'22.160"N 90°27'42.400"E. From point No. 14 the boundary proceeds in Eastern direction along the same A'king Land boundary till it reaches point No. 15 at 25°11'21.308"N 90°27'47.403"E then it continue to proceed further in South Eastern direction till it reaches point No. 16 at 25°11'18.420 N 90°27'49.700"E, from point No. 16 it run along the same A'king Land in Eastern direction till it reaches point No. 17 at 25°11'19.384"N 90°27'51.857"E then it continue to proceed further in Eastern direction till reaches point No. 18 at 25°11'19.410"N 90°27'54.245"E. From the point No. 18 the boundary proceeds in Southern direction along the boundary of Aritakgre A'king land till it reaches point No. 19 at 25°11'18.352" N 90°27'54.688"E, then it continue to run along the same A'king Land boundary towards East till it reaches point No. 20 at 25°11'17.800"N 90°27'59.250"E. From point No. 20, the boundary proceeds in Northern direction along the same boundary line till it reaches point No. 21 at 25°11'20.215"N 90°27'59.457"E, then it continue to proceeds further North-eastern direction along the boundary of the said Land of the Aritakgre A'king Land till it reaches point No. 22 at 25°11'20.945 N 90°28'1.483"E. From the point No. 22, the boundary proceeds in Northern direction along the boundary of said Land of the Aritakgre A'king Land till it reaches point No.23 at 25°11'22.722"N 90°28'1.392"E. From the point No.23 the boundary proceeds Eastward along the boundary of the said Land of Aritakgre A'king till it reaches point No. 24 at 25°11'23.568"N 90°28'4.583"E, then it continue to run along the said land towards North-Eastern direction till it reaches point No. 25 at 25°11'22.356"N 90°28'5.763"E, then it continue to run along the same land boundary eastward till it reaches point No.26 at 25°11'22.009"N 90°28'9.054"E up to point No. 27 at 25°11'21.233"N 90°28'9.739"E. From the point No. 27 the boundary proceeds in Southern direction along the said boundary of the Aritakgre A'king Land upto point No. 28 at 25°11'18.852"N 90°28'9.531"E. From point No.28, the boundary proceeds in South-Eastern direction along the small stream till it reaches point No. 29 at 25°11'17.591"N 90°28'11.294"E then it continue to run along the same stream up to point No.30 at 25°11'17.850"N 90°28'13.640"E.

EAST: Eastern boundary starts from point No. 30 at 25°11'17.850"N 90°28'13.640"E and proceeds South Western direction along the boundary of Aritakgre A'King Land till it reaches point No.31 at 25°11'16.975"N 90°28'12.732"E, then it proceeds further in the Southern direction along the said boundary of the Aritakgre A'king Land till it reaches point No. 32 at 25°11'14.844"N 90°28'13.796"E then it continue to proceed in Southern direction along the same land boundary till it meet at point No. 33 at 25°11'13.358"N 90°28'13.566"E.

SOUTH: Southern boundary starts from point No.33 at 25°11'13.358"N 90°28'13.566"E located on Aritakgre Nokma Land boundary then proceeds Western direction along the Aritakgre A'king Land boundary then to point No. 34 at 25°11'13.200"N 90°28'12.640"E. From the point No. 34, the boundary proceeds in Northern direction along the Nokma Land boundary of Aritakgre Aking Land till it reaches point No. 35 at 25°11'14.853"N 90°28'12.523"E then it continue run towards Western direction along the same A'king Land boundary till it meet point No. 36 at 25°11'14.964"N 90°28'7.729"E then to point No. 37 at 25°11'14.862"N 90°28'6.039"E then to point No. 38 at 25°11'13.496"N 90°28'4.079"E then to point No. 39 at 25°11'12.808"N 90°28'2.234"E then to point 40 at 25°11'13.181"N 90°27'57.705"E then to point No. 41 at 25°11'14.327"N 90°27'54.827"E then to point No. 42 at 25°11'13.347"N 90°27'49.236"E then to point No. 43 at 25°11'12.607"N 90°27'44.534"E and then to point No. 44 at 25°11'11.492" N 90°27'43.148"E. From the point No. 44, the boundary proceeds in Southern direction along the same A'king Land boundary till it reaches point No. 45 at 25°11'10.501"N 90°27'43.553"E then it continue to proceed in Southern direction then to point No. 46 at 25°11'7.665"N 90°27'42.786"E then to point No. 47 at 25°11'4.458"N 90°27'42.062"E till it reaches point No. 48 at 25°11'1.700"N 90°27'38.920"E. From the point No. 48, the boundary proceeds in Western direction along the Kapasipara A'king Land boundary then to point No. 49 at 25°11'3.759"N 90°27'34.459"E then it continue run along the same A'king Land boundary then to point No. 50 at 25°11'5.551"N 90°27'33.592"E then to point No. 51 at 25°11'6.715"N 90°27'31.620"E then to point No. 52 at 25°11'6.604"N 90°27'29.122"E then to point No. 53 at 25°11'7.997"N 90°27'26.233"E then to point No. 54 at 25°11'11.121"N 90°27'24.552"E and then to point No. 55 at 25°11'12.792"N 90°27'22.785"E. From the point No. 55, the boundary proceeds in Western direction along the small stream till it reaches point No. 56 at 25°11'12.280"N 90°27'21.280"E and up to point No. 57 at 25°11'13.454"N 90°27'19.491"E located at Chimajado A'king Land boundary.

West: Western boundary starts from point No. 57 at 25°11'13.454"N 90°27'19.491"E then it proceeds in Northern direction along the Chimajado A'king Land boundary till it reaches point No. 58 at 25°11'17.220"N 90°27'21.950"E then it continue run along the same A'king Land boundary till it reaches point No. 59 at 25°11'20.336"N 90°27'20.909"E then point No. 60 at 25°11'23.152"N 90°27'21.620"E then to point No. 61 at 25°11'25.610"N 90°27'21.772"E then to point No. 62 at 25°11'26.605"N 90°27'22.821"E then to point No. 63 at 25°11'29.891"N 90°27'23.263"E then it proceeds in North Eastern direction along the same A'king Land boundary point No. 64 at 25°11'31.189"N 90°27'25.040"E till it reaches starting point of the Northern boundary at point No. 1 at 25°11'32.350"N 90°27'25.330"E.

AREA : 60.6 hac. Approximately.
