ORDERS BY THE GOVERNOR

NOTIFICATION

Dated Shillong, the 28th February, 2022.

NO.FOR.17/2013/542 :- In accordance with the provisions of Section 36 C of the Wild Life (Protection) Act, 1972(as amended upto 2006), the Governor of Meghalaya is pleased to declare the Village Forest of Dorbar Shnong Thangrain Village, West Jaintia Hills District, as a Community Reserve to be known as the "Kremlongjiah Community Reserve" with immediate effect as per the schedule of boundaries indicated below:-

Schedule of Boundaries:-

North: Northern boundary starts from Point No. 1 at 25° 35' 27.192" N 92° 23' 51.874" E then it proceeds in South-Eastern direction along the Umladoh stream upto Point No. 2 at 25° 35' 26.693" N 92° 23' 52.798" E then it proceeds Eastward along the Umladoh stream upto Point No. 3 at 25° 35' 26.836" N 92° 23' 54.011" E. From Point No. 3, the boundary proceeds in South-Eastern direction along the Umladoh stream till it reaches Point No. 4 at 25° 35' 26.256" N 92° 23' 55.209" E then it proceeds in North-Eastern direction along Umladoh stream up to the point till it reaches Point No. 5 at 25° 35' 26.584" N 92° 23' 55.701" E then it continues to proceed further in North-eastern direction along Umladoh stream till it reaches Point No. 6 at 25° 35' 26.940" N 92° 23' 58.373" E.

East: From the Point No. 6, at 25° 35' 26.940" N 92° 23' 58.373" E the boundary proceeds towards south-eastern direction along the boundary of the Thangrain village forest till it reaches Point No. 7 at 25° 35' 25.818" N 92° 23' 59.289" E and then it proceeds further in south eastern direction along the boundary of Thangrain village forest upto Point No. 8 at 25° 35' 24.485" N 92° 24' 0.307" E then it continues to proceed further in south eastern direction along the boundary of Thangrain Village Forest at Point No. 9 at 25° 35' 23.155" N 92° 24' 2.490" E. From the Point No. 9, the boundary proceeds in South ward direction along the boundary of Thangrain Village forest till it reaches Point No. 10 at 25° 35' 21.212" N 92° 24' 2.879" E then it continues to proceed further in South ward direction along the boundary of Thangrain village Forest till the point where it meets the Kutcha road to Thangrain Village at Point No. 11 at 25° 35' 19.355" N 92° 24' 2.964" E and then along the Kutcha road in south western direction up to Point No. 12 at 25° 35' 16.310" N 92° 24' 1.424" E. From the Point No. 12, the boundary proceeds in south western direction along the Kutcha Road towards Thangrain village till it reaches Point No. 13 at 25° 35' 14.718" N 92° 24' 0.578" E then it continues to proceed further in south western direction along Kutcha Road upto Point No. 14 at 25° 35' 13.871" N 92° 23' 59.615" E and then south ward upto Point No. 15 at 25° 35' 12.711" N 92° 23' 59.532" E. From the Point No. 15, the boundary proceeds in South-western direction along the Kutcha Road till it reaches Point No. 16 at 25° 35' 10.423" N 92° 23' 57.868" E then it continues to proceed further in South western direction till it reaches the Tre Hali Rud Shnong at Point No. 17 at 25° 35' 10.228" N 92° 23' 56.465" E. From the Point No. 17, the boundary proceeds along the Tre Hali rud Shnong in south western direction upto point No. 18 at 25° 35' 9.778" N 92° 23' 55.804" E then it proceeds further in south western direction along the Tre Hali rud Shnong at Point No. 19 at 25° 35' 7.619" N 92° 23' 53.728" E. From the Point No. 19, the boundary proceeds west ward along the boundary of the Tre Hali rudshnong till it reaches Point No. 20 at 25° 35' 7.681" N 92° 23' 52.039" E then it proceeds in south western direction till it reaches Point No. 21 at 25° 35' 4.663" N 92° 23' 50.746" E and further South western direction along the boundary of Tre Hali rudshnong till it reaches Point No. 22 at 25° 35' 1.943" N 92° 23' 49.735" E.

South: From the Point No. 22, the boundary proceeds West ward along the boundary of hali Tre kor till it reaches point No. 23 at 25° 35' 1.533" N 92° 23' 46.190" E then it proceeds in South-Western direction till it reaches Point No. 24 known as wahhali Tre Kor at 25° 35' 0.757" N 92° 23' 45.587" E. From the Point No. 24, the boundary proceeds in North west direction along the nala of Wah Hali trekor which is also the foot hills of Lum Mooblai up to Point No. 25 at 25° 35' 1.972" N 92° 23' 39.966" E then it proceeds in South West direction along the wahhalitrekor upto Point No. 26 at 25° 35' 1.138" N 92° 23' 37.979" E. From Point No. 26 the boundary proceeds in the North West direction along the

wahhalitrekor till it reaches Point No. 27 at 25° 35' 2.167" N 92° 23' 36.225" E and further north west direction up to point No.28 at 25° 35' 3.139" N 92° 23' 35.256" E and further upto point No.29 the meeting point of Wah Umladoh Stream at 25° 35' 3.923" N 92° 23' 33.431" E.

West: From Point No. 29 at 25° 35' 3.923" N 92° 23' 33.431" E, the boundary proceeds North ward along the Umladoh stream up to point No.30 at 25° 35' 4.559" N 92° 23' 33.276" E, then from point No.30 along the Umladoh stream up to point No.31 at 25° 35' 5.454" N 92° 23' 33.367" E. From Point No.31 the boundary proceed North East direction along the Umladoh Stream upto to point No.32 at 25° 35' 5.748" N 92° 23' 33.688" E and from Point No.32 the boundary proceed in the North ward direction along the Umladoh stream up to Point No. 33 at 25° 35' 6.763" N 92° 23' 33.834" E then it continues to proceed along the Umladoh stream till it reaches Point No. 34 at 25° 35' 6.851" N 92° 23' 34.384" E" and then north ward upto Point No. 35 at 25° 35' 7.232" N 92° 23' 34.363" E. From Point No. 35 the boundary then proceeds in North-Eastern direction along the Umladoh stream upto Point No. 36 at 25° 35' 7.874" N 92° 23' 36.181" E then to Point No. 37 at 25° 35' 10.032" N 92° 23' 38.086" E and further upto Point No. 38 at 25° 35' 11.244" N 92° 23' 39.976" E. From Point No. 38 the boundary proceeds north ward upto Point No. 39 at 25° 35' 11.865" N 92° 23' 40.064" E. From the Point No. 39, the boundary proceeds north east direction along the said stream till it reaches Point No. 40 at 25° 35' 13.644" N 92° 23' 42.241" E then it proceeds further in north east direction along the said stream till it reaches Point No. 41 at 25° 35' 15.414" N 92° 23' 42.703" E and then further upto Point No. 42 at 25° 35' 17.857" N 92° 23' 45.956" E and up to Point No. 43 at 25° 35' 19.701" N 92° 23' 46.744" E. From Point No. 43, the boundary proceeds along the Umladoh Stream in North West direction upto point No. 44 at 25° 35' 20.473" N 92° 23' 46.266" E and further North East upto Point No. 45 at 25° 35' 21.196" N 92° 23' 46.414" E. From Point No.45, it proceeds in North eastern direction along the said stream till it reaches Point No. 46 at 25° 35' 21.440" N 92° 23' 47.019" E then it proceeds south east ward along the said stream till it reaches point No.47 at 25° 35' 20.592" N 92° 23' 47.913" E then it proceeds further in South east direction till it reaches point No.48 at 25° 35' 20.322" N 92° 23' 49.272" E. From point No.48 the boundary proceeds in North East direction along the Umladoh stream up to point No.49 at 25° 35' 21.747" N 92° 23' 50.636" E and it proceeds further North East direction upto point No.50 at 25° 35' 22.689" N 92° 23' 51.265" E. From Point No.50, the boundary proceeds in North West direction along the Umladoh Stream upto point No.51 at 25° 35' 23.495" N 92° 23' 51.049" E and then North Ward up to point No.52 at 25° 35' 25.298" N 92° 23' 51.506" E and from point No. 52 the boundary proceeds further North upto point 53 at 25° 35' 26.493" N 92° 23' 51.245" E. From point No.53 the boundary proceeds in North East direction upto point No. 1 at 25° 35' 27.192" N 92° 23' 51.874" E which is the starting point of the boundary.
