NOTIFICATION

No. ITC.45/2022/1

Shillong, the 17th November 2022

WHEREAS, the Department of Telecommunications (DoT), Ministry of Communications, Government of India, envisages "Broadband for All" under the National Broadband Mission (NBM);

AND WHEREAS, in order to achieve the goals of NBM and to roll out 5G services, the Telecom Service providers (TSPs) and Infrastructure Providers (IPs) need to enhance fiberisation of Towers/ Base Transceiver Station (BTSs) by utilising the existing fibres laid by PSUs, fibre laid under BharatNet and fibre sharing amongst TSPs and also to lay additional Optical Fibre Cables (OFC) and erect / use Towers / Poles in the nook and corner of the country;

AND WHEREAS, a large densification of mobile network and access to the street furniture is essential for deploying 5G small cells, to be installed close to every 200 metres;

AND WHEREAS, the utilization of the Government infrastructures such as Government offices / properties / buildings, bus terminals, electric poles, traffic junctions, school buildings etc. is essential to enable such a mega roll-out of mobile towers / poles with minimal charges;

AND WHEREAS, the Government of Meghalaya constituted the State Broadband Committee (SBC) on 18th June 2020, chaired by the Chief Secretary, to realize the objectives of the National Broadband Mission (NBM);

NOW, THEREFORE, in order to ensure "Broadband for All" under National Broadband Mission, with key emphasis, inter alia, on the rollout of 5G network in Meghalaya, the Governor of Meghalaya is pleased to constitute the "Working Committee under SBC" under the State Broadband Committee (SBC) as per the following composition:

Terms of Reference: The Terms of Reference (ToR) of the Working Committee under SBC shall be as follows:

- (i) To recommend issuance of necessary addenda and amendment in the existing Meghalaya Telecom Infrastructure Policy 2018.
- (ii) To chalk out strategy for rolling out 5G infrastructure
- (iii) To take appropriate measures in alignment with the Digital Communication Readiness Index (DCRI)
- (iv) To strategize and implement modalities for use of street furniture and other infrastructure for establishing telecom infrastructures
- (v) To implement a system for identification of street furniture and data collection methodology in a standard uniform format.
- (vi) To ensure updation of inventory and reporting in the centralized Gati Shakti RoW portal by respective Departments.
- (vii) To ensure that the centralized Gati Shakti RoW portal facilitates different Departments for online approval of street furniture, including bulk approval options.
- (viii) To conduct monthly review on administrative issues and improvement areas.
- (ix) To identify the designated Nodal officers who shall be responsible for resolving the issue related to specific domains / Departments and the contact details shall be made publicly available.
- (x) To explore simplification of the Power consumption bill. The collective load of all 5G cells in one area / for one operator may be considered as one connection and accordingly flat electricity charges may be applied for street furniture and poles for 5G rollout.
- (xi) To ensure expeditious upgradation of electricity capacity through dedicated teams assigned by Discoms - Meghalaya Energy Corporation Ltd (MeECL) / Meghalaya Power Distribution Corporation Ltd (MePDCL) and to track all pendencies and intervene for resolution. The Discoms to apprise the Working Committee under SBC the foreseeable timelines on the closure of the upgradations.
- (xii) To explore possibility of competitively aligning electricity pole usage charges in coordination with stakeholders.
- (xiii) To ensure security related aspects are addressed such as theft of communication infrastructures i.e batteries, cables, optical fibre cables (OFC) etc.
- (xiv) To coordinate with Urban Affairs Department for alignment with the latest guidelines and notifications of the Ministry of Housing and Urban Affairs (MOHUA), Government of India.
- (xv) Any other related matter for the furtherance of the overall objectives of the National Broadband Mission (NBM) and 5G rollout in Meghalaya.

The Chairperson of the Working Committee under SBC may co-opt members as may be deemed necessary from time to time.
