The term of reference of the Committee will be as follows:-

The Committee will examine the complaints of the employees belonging to Schedule Tribes belonging to the jurisdiction of Programme Implementation & Evaluation Department, Government of Meghalaya, on matters such as –

- i. Non-maintenance of reservation in roster and not filling up of reserved vacancies.
- ii. Discrimination in promotion/seniority/MACP/ACP.
- iii. Non-appointment on compassionate grounds.
- iv. Adverse/downgrading of APARs.
- v. Termination/dismissal from services.
- vi. Discrimination in transfer/posting.
- vii. Denial of pensioner benefits etc.

Member-Secretary will ensure a quarterly report for the Department as per the prescribed format and submit to Social Welfare Department.

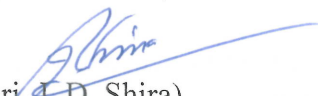
