## Functions of the State Assessment Board for Persons with High Support Needs

- 1. The Authority notified under Section 38 (1) of the Rights of Persons with Disabilities Act, 2016 shall refer every case to the Assessment Board for assessment of application's high support requirement.
- 2. The State Government may develop dedicated schemes to provide high support to such persons with benchmark disabilities.
- 3. The Authority notified under sub-rule (1) shall consider the application for high support requirement on the basis of the recommendations of the Assessment Board keeping in view the schemes or programmes of the respective State Government.
- 4. To make specific recommendation on any requirement as forwarded by the Assessment Board.
