**No.VET (SCH) 8/2008/633** – The Governor of Meghalaya is pleased to notify the Director of Animal Husbandry and Veterinary as Single Nodal Agency (SNA) for Integrated Sample Survey (ISS) Scheme and Joint Director (Statistics) as Nodal Officer for Integrated Sample Survey (ISS) / State Implementing Agency for implementing the Integrated Sample Survey (ISS) National Livestock Mission (NLM).

**Function of the Single Nodal Agency (SNA)/State Implementing Agency for Integrated Sample Survey (ISS) Scheme.**

- The Single Nodal Agency for implementation of the Integrated Sample Survey Scheme is to estimate the production of Major Livestock Product (MLP) namely milk, eggs, meat and wool on the basis of Annual Sample Surveys.
- The scheme is not beneficiary oriented scheme. It is planned to supplement other schemes, with relevant and reliable statistics
- The State Implementing Agency shall be responsible for all activities of Survey as per schedule with desired accuracy and as per requirement of Government of India.
