## OFFICE MEMORANDUM

Subject

Scheme for payment of Pension by Public Sector Banks.

The Undersigned is directed to refer to this Department's letter NO.FEM(PC)24/87/392, dated 16.03.1988 and to say that the scheme for payment of pension through Public Sector Banks shall stand modified as follows:-

Para 1 - For the existing paragraph 1 the following shall be substituted viz., 'The scheme for payment of pension of Meghalaya Government Pensioners through Public sector Banks will extend to the whole State of Meghalaya and will cover all pensioners of the Government of Meghalaya and holders of family pension of this State Government. The Scheme will also cover All India Service Officers who retire/retired from a post under the Government of Meghalaya.

Para 2 - For the existing paragraph 2, the following shall be substituted viz. The Government of Meghalaya may, on the request of the Government of any State/Union Territory where also a similar Scheme of payment of pension through Public Sector Banks is in force, permit by a specified order issued in this regard the drawal of pension in respect of their pensioners through Public Sector Banks within this State. The payment of pension in such cases would likewise be admissible only through the Public Sector Banks which are selected under this Scheme. The procedure to be observed in connection with the switch over of payment from the Treasury to the Bank and payment by the Banks, in such cases, will be also the same as prescribed under this Scheme.

Para 10 - The existing para 10 is renumbered and denoted as para 10 (1) and immediately thereafter a sub-paragraph (2) shall be added viz.,

(2) The payment of pension of other State/UnionTerritory Government(s) as permitted vide para 2 at the paying branches of the Public Sector Banks will be distinctly shown by the Banks in the payment scrolls against the respective State/Territory Government(s) to whom the payment is debitable. The payment will, however, be initially taken against the cash balances of the State Government in which the paying branch of the Bank is situated.
