ANNEXURE-I**Eligibility criterion for the post of Secretary-Cum-Controller of Examinations, Staff Selection Commission (Hqrs), New Delhi**

1. Name of Post : Secretary-Cum-Controller of Examinations, Staff Selection Commission (Hqrs), New Delhi.
2. Scale of Pay : PB-4, Rs. 37,400-67,000 + Grade Pay of Rs. 8700/-.
3. Eligibility : Officers of the Central Government (including officers of All India Services and Central Group 'A' Services).
 - (a) (i) holding analogous post on regular basis in the parent cadre/Department; or
 - (ii) with five years service in the grade rendered after appointment thereto on regular basis in the scale of pay of Rs. 12,000-16,500/- (pre-revised) (revised pay scale-PB-3 with Grade Pay of Rs. 7,600/-) or, equivalent in the parent cadre/Department;and
- (b) Possessing the following educational qualification and experience:-
 - (i) Master's Degree from recognized University or equivalent and;
 - (ii) Seven Year's experience in Administration, Vigilance and Financial Matters.
4. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government, shall ordinarily not exceed three years.
5. **Age limit**: The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.
