#### Increase in upper age limit for entry into Government Service.

The Governor of Meghalaya is pleased to order that the upper age limit for entry into Government Service is hereby enhanced from 27 to 32 years i.e. he/she must not have exceeded the age of 32 on the first day of the year of advertisement. Candidates belonging to Scheduled Tribes and Scheduled Castes will continue to enjoy a further relaxation of 5 years over the upper age limit of 32 years.

The new upper age limits will be applicable in case of all categories of posts except for certain categories of posts as may be notified by the Personnel & A.R.(A) Department for the Home (Police), Excise Registration Taxation and Stamps, Home Guards & Civil Defence, Prisons and Forests & Environment Departments.

This order shall take effect from the date of issue of this Memorandum.
