Function of the Committee:

- 1. The State Child Welfare and Protection Committee under the Chairpersonship of the Principal Secretary/Commissioner & Secretary/Secretary, Social Welfare Department shall supervise the implementation of Mission Vatsalya Child Protection Services(CPS) Scheme, with the help of the State Child Protection Society (SCPS).
- 2. The Committee shall prepare an annual action plan including financial proposal for the state and submit to the Ministry for approval.
- 3. The Committee shall closely monitor and review the working of structures, services and progress under various components of Mission Vatsalya and hold quarterly review meetings with District Child Welfare and Protection Committees for effective implementation of the scheme.
- 4. The State Committee shall take needful measures for advocacy, awareness generation, capacity building, of all stakeholders on child rights and child welfare, and address roadblocks, issues, complaints received regarding care and protection of children in the State.
- 5. The State Committee shall make special efforts for convergence so as to ensure benefits under all possible government welfare schemes for the children.
- 6. The State Committee shall ensure that all institutions are set up under the Juvenile Justice (Care and Protection of Children) Act, 2015, and Rules thereof.
- 7. The Chairperson may invite any other domain expert/statutory body/invitees/departments to attend the meeting of the Committee.
- 8. The State Committee with the assistance of SCPS may also frame a media and communication plan to generate awareness among the public on various aspects of the Mission for the rehabilitation and procedures for better protection of children.
- 9. The State Child Welfare and Protection Committee may rationalize the existing manpower in the implementing agencies for optimum utilization of resources as per the number of blocks, case load and inter-district transfers on need basis to address administrative exigencies.
- 10. The State can rationalize manpower distribution per DCPU as per the work load/ number ofblocks within the districts.
