Function of the Convergence Plan Committee for Shillong Urban ICDS

- 1. Need assessment of essential interventions at the Village / AWC level, i.e., water, sanitation, food, health interventions, immunization, ANC/PNC, Vitamin A, IFA, Deworming Tablets, functioning of VHSNC etc and the availability of resources.
- 2. The assessment at the village level will be done by the Anganwadi Worker and Supervisor in association with the village Durbars under the supervision of the Child Development Project Officer / District Programme Officer. The C.D.P.O. / D.P.O. would submit the inputs to the area Sub-Divisional Magistrate.
- 3. Consolidate and assess the requirement of interventions at the Block level.
- 4. Considering the need, each line department at the block level to propose their action Plan at the Block level for inclusion in the District Action Plan.
- 5. Involve Village Durbars actively in assessing the need and seek their suggestion.
- 6. Submit the Block Convergence Plan to the District Authorities for inclusion in the District Action Plan and approval of District Magistrate.
