Role and Responsibilities :

- 1) To ensure that the Internal Complaint Committee (ICCs) in all Workplaces and Local Complaints (LCs) in all Districts are constituted.
- 2) To ensure effective implementation of the Prevention of Sexual Harassment of Women at workplace (Prevention, Prohibition and Redressal) Act 2013, including awareness and sensitization programme/giving wide publicity etc.
- 3) To ensure monitoring and reporting of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 i.e, Annual Reports form all Workplaces/Departments/institutions/organizations are to filed for the Financial Year to the Office of the Deputy Commissioner.
- 4) Non-Compliance of filing Annual Reports or establishing Internal Complaint Committee will attract a penalty as laid out in the Act and the office of the Deputy Commissioner will ensure this is strickly adhered.
