ORDERS BY THE GOVERNOR
NOTIFICATION**

Dated Shillong, the 19th December, 2022.

No.UAU.100/91/Pt/198– In pursuance to Government Notification No. UAU.85/2001/Pt/63 dated 10.08.2022 and UAU.85/2001/Pt/64 dated 25.10.2022 the Governor of Meghalaya is please to place Shri B.R.M. Lyngdoh, District Urban Planner on deputation as Director, Meghalaya Urban Development Agency, Shillong with effect from the date of joining on the following terms and conditions of deputation (duty allowances on 'Foreign Service) as laid down in Finance Department's Office Memorandum No. FEG.62/81/5 dated 19.08.82 read with Office Memorandum No.FEG.9/2018/15 dated 07.03.2018.

1. **Period of Deputation:** One year at the first instance.
2. **Salary:** During the period of his deputation, the Officer shall be entitled to draw his own grade pay and allowances as admissible under the State Government plus deputation allowance at the rate of 10% of the employee basic pay subject to a maximum of ₹4000/- provided that the basic pay plus deputation allowance shall at no time exceed ₹1,42,900/- or the maximum of the scale of pay of the deputation post.
3. **Dearness Allowance etc:** During the period of deputation as Director, Meghalaya Urban Development Agency, he will be entitled of Dearness Allowance under the rules of the parent department or the rules of Meghalaya Urban Development Agency, according to his option to draw either his own grade pay in his parent Department or the pay of the deputation post under Meghalaya Urban Development Agency.
4. **Joining time TA/DA:** He will be entitled to joining time on deputation and on reversion there from to his parent Department and T.A/D.A for his journey performed on tour in connection with the works of the Meghalaya Urban Development Agency will be paid by and under the rules of the Meghalaya Urban Development Agency.
5. **Leave Salary and Pension Contribution:** Contribution of leave salary and pension contribution during the period of deputation will be paid by the borrowing authority according to rate, enforce from time to time.
6. **Payment of leave salary during the disability leave:** The borrowing authority will be liable to pay the leave salary in respect of any disability incurred in and through service under the Foreign Employer and even if such a disability manifests itself after the termination to service under the Foreign employer.
7. **Pension and contribution Provident fund:** During the period of deputation he will not be allowed to join any pension and General Provident Fund Scheme.
8. **Medical Facilities:** During the period of deputation he will be entitled to medical facilities not inferior to those which he would have enjoyed in his parent Department but for his deputation.

9. **Grant of Gratuity or Pension for injury or death:** The Meghalaya Urban Development Agency will be liable to pay any gratuity or pension that is admissible under the rules. If any injury is sustained or death occurs during the service on deputation to Meghalaya Urban Development Agency.
10. **Compensatory allowance:** The whole expenditure in respect of any compensatory allowance for the period of leave during or at the end of service on deputation will be borne by Meghalaya Urban Development Agency.
11. **Local allowance:** During the period of deputation to Meghalaya Urban Development Agency he will be entitled to draw the local city allowance, H.R.A and other local allowance according to the rules of the Meghalaya Urban Development Agency.
12. **Leave Rules:** During the period of deputation, he will be governed by the leave rules applicable to him in his parent Department.
13. **Movable and Immovable Properties:** The officer concerned will regularly furnish return of his movable and immovable properties owned by him to his parent Department.
14. **Commencement and Termination of Deputation Services:** The date of commencement of the services on deputation will be the date on which the officer handed over charge of the post in his parent Department/Office and the date of termination will be the date he takes over charge of the post in his parent Department/Office as provided under F.Rs and S.Rs.
