**NOTIFICATION**

**Dated Shillong, 26<sup>th</sup> May 2025**

**No. UAU.5/2017/Pt.III/429** - In exercise of the powers conferred by Section 18 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014), and subject to the provisions of this Act or any rule or scheme made thereunder, and in compliance with the order issued by the Hon'ble High Court of Meghalaya in PIL No. 17 of 2021, dated 28<sup>th</sup> October 2024, which directed the State Government to demarcate areas where street vending can be allowed or otherwise, certain areas across Khyndailad have been notified as Vending Zones vide letter No.UAU.5/2017/123 dated 17th of December, 2024.

In continuation of the above, all remaining areas of Khyndailad (Ward No. 9 of Shillong Municipal Board), excluding the areas already notified as Vending Zones, are hereby notified as 'No Vending Zones'.

All street vending activities are prohibited in the specified area. Non-compliance will result in penalties as per the provisions of the Meghalaya Street Vendors Scheme (Protection of Livelihood and Regulation of Street Vending), 2023.
