NOTIFICATION**

Dated Shillong, the 05th August, 2026

No.UAU.5/2017/Pt.IV/116 – In continuation of this Department's Notification No.UAU.5/2017/Pt.IV/105 Dt.12.05.2026 and in exercise of the powers conferred by Section 21 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014), and subject to the provisions of this Act or any rule or scheme made thereunder, and in compliance with the order issued by the Hon'ble High Court of Meghalaya in PIL No.17/2021, dated 28th October 2024, which directed the State Government to demarcate areas where street vending can be allowed or otherwise, the entire stretch of road **within the Polo and Lawmali areas**, except the designated street vending locations notified vide Notification No.UAU.5/2017/Pt.IV/105 Dt.12.05.2026, are hereby notified as as a **"No Vending Zone"** with immediate effect for smooth traffic flow, pedestrian safety and public convenience.

All street vending activities are prohibited in the specified area. Non-compliance will result in penalties as per the provision of the Meghalaya Street Vendors (Protection of Livelihood and regulation of Street Vending) Scheme 2023.
