3. The Terms of Reference of the Committee shall be as follows :-

- (a) To Coordinate actions of concerned Departments/Authorities including Autonomous District Councils on important matters relating to mineral development and regulation in the State.
- (b) To remove bottlenecks in mineral concession applications and renewal application pending with the concerned authorities and suggest corrective measures for expediting their disposal as per the Rules.
- (c) To improve e-governance systems including computerized processing, data management and dissemination.
- (d) Development, implementation and evaluation of sustainable development framework.
- (e) Co-ordination and review of steps for prevention and detection of irregular mining

The Committee shall meet at least once in 6 months.
