ORDERS BY THE GOVERNOR

NOTIFICATION

Dated Shillong, the 10th January, 2013.

No.HPL.164/2010/319 – Whereas for public convenience and better administration the Governor of Meghalaya considers it necessary to create a new Police Out Post at Rongsai in the West Garo Hills District to be known as the Rongsai Police Out Post;

And, whereas, it is necessary to describe the boundaries and jurisdiction of the new Out Post as indicated here-under;

Now, therefore, the Governor of Meghalaya is pleased to order creation of the aforesaid Out Post at Rongsai and to describe the boundaries and jurisdiction of the new out Post as indicated hereunder with effect from the date of publication of this Notification in the Official Gazette of Meghalaya. On creation of the Rongsai Out Post, the areas coming under its jurisdiction shall cease to be under the Tikrikilla Police Station.


DESCRIPTION OF THE BOUNDARIES OF THE RONGSAI OUT POST

North : From Tri – junction of Rongsai under Lakhipur P.S jurisdiction of Assam in the Western direction along the AMPT Road and interstate boundary of Assam – Meghalaya up to Medipara.

East : From Rongsai Tri – junction boundary runs along the Rongsai River crossing Roni stream, covering Pedaldoba, Noapara, Dobokjakolgre, Tosinpara towards Jengritgre village, and Gindopara village area up to Didram River bordering Western part of Bajengdoba P.S area of East Garo Hills District.

South : From Didram or Jinnai River running towards westerly direction covering Silsekgre, Chikasingre bordering northern part of Tura P.S Jurisdiction.

West : From Tri – junction of Medhipara boundary runs covering Kalitapara, Kalajhar, Megaapara, Kakunanggre, Rengigre crossing Didram or Jinnai River up to Mengotchigre and Aigre village area bordering Eastern part of Tikrikilla P.S jurisdiction.


