PRESS RELEASE

On 07.12.2020, an FIR was received at Mawngap P.S that Shri Teren Mawlieh had committed penetrative sexual assault on his minor step daughter. Accordingly, a case vide Mawngap P.S Case No. 49(12)2020 u/s 354/354A/354B/376(2)(f)/376(3)/503/506 IPC r/w Sec 3(b)/5(n)/6/7/9(l)(n)/10 POCSO Act was registered. The case was investigated and consequently the accused, Shri Teren Mawlieh was arrested. On completion of the investigation, the Investigation Officer filed the Charge Sheet vide CS No. 03/2021 Dated 05/02/2021 u/s 5(l)(m)(n)/6 POCSO Act.

On 28th August, 2026, the Hon'ble Court of Smti. M.K. Lyngdoh, Spl. Judge (POCSO), East Khasi Hills, Shillong vide Judgment/Court Order Dated 28/08/2026 convicted the accused, **Shri Teren Mawlieh** of Spl. (POCSO) Case No. 06 of 2021 arising out of Mawngap P.S Case No. 49(12)2020 u/s 354/354A/354B/376(2)(f)/376(3)/503/506 IPC r/w Sec 3(b)/5(n)/6/7/9(l)(n)/10 POCSO Act. The accused is sentenced to **20 (twenty) years** imprisonment with **fine of Rs. 30,000/-** for an offence **u/s 4 of POCSO Act** and in default of payment of fine, further simple imprisonment for 3 (three) months. The accused is also sentenced **30 (thirty) years rigorous imprisonment** with fine of **Rs. 40000/-** for an offence **u/s 6 of POCSO Act** and in default of payment of fine, further simple imprisonment for 4 (four) months. The accused is also sentenced **5 (five) years imprisonment** with fine of **Rs. 10000/-** for an offence **u/s 8 of POCSO Act** and in default of payment of fine, further simple imprisonment for 1 (one) month. The accused is also sentenced **7 (seven) years imprisonment** with fine of **Rs. 20000/-** for an offence **u/s 10 of POCSO Act** and in default of payment of fine, further simple imprisonment for 1 (one) month. The convict has already undergone a period of 3 (three) years, 11 (eleven) months, and 28 (sixteen) days of imprisonment. He shall therefore serve the remaining sentence of **26 (twenty six) years and 2 (two) days** in jail.

The case was investigated by WPSI L. Kharjana presently at Women P.S, East Khasi Hills District.
