 - (i) Notice No. SHEL.V/MP/26/2024/9/21/92 dated 13th April, 2024 issued by the Returning Officer, 1- Shillong Parliamentary Constituency to Shri Vincent H Pala, Contesting INC Candidate against the advertisement issued on behalf of the All India Congress Committee on Facebook. The Committee after considering the reply submitted by Shri Sunday Barch, Election Agent for Shri Vincent H. Pala, INC Candidate, Shillong Seat, decided the same as not paid advertisement/news.
- 2. The Committee was informed that the declaration about criminal antecedents of candidates of (1) Shri Robertjune Kharjahrin of United Democratic Party (UDP) as published on newspapers Rupang on 3rd and 6th April, 2024 & The Times of India on 11th April, 2024 and of (2) Dr. Mazel Ampareen Lyngdoh of National People's Party (NPP) as published on newspaper U Peitngor on 3rd and 13th April, 2024 has been reported to the Accounting Team 1-Shillong Parliamentary Constituency for information and necessary action.
 - 3. The District MCMC has decided to issue and advisory to the print & electronic media and the local cable operators on what must be avoided during the period of 48 hours ending with the hours fixed for the conclusion of the poll, i.e. 4:00 P.M. of the 19th April, 2024, referred to in Section 126 of the Representative People Act, 1951 to ensure that no Political Party or Candidate or any other organization or person publishes any Advertisement on poll day and one day prior to the poll day, unless the contents of such political advertisements are pre certified by the State/ District level MCMC. the case may be, and that contents telecast/broadcast/displayed by them during the period referred to above do not contain any materials, including views/appeals by panelists/ participants that may be construed as promoting/prejudicing the prospect of any particular party or candidate or influencing/affecting the result of the election.

The meeting ended with a vote of thanks from the chair.
